We Care Postpartum program



Caring for the health of you and your baby every step of the way.

After your baby is born, we have a postpartum program you may be eligible to join. The **Postpartum program** offers an incentive for receiving your postpartum exam and taking your newborn to his or her first two-week, well-child visit. Program benefits include:

- The opportunity to earn prepaid **\$25 Visa gift cards** for completing a postpartum doctor visit within 7-84 days after delivery (with a maximum of \$75 per Enrollee, per year)
- Educational classes (safe sleep training—including free cribette)
- Assistance with community resources
- Care manager nurse assistance for Enrollees experiencing high-risk chronic conditions, depression, and/or social determinants of health
